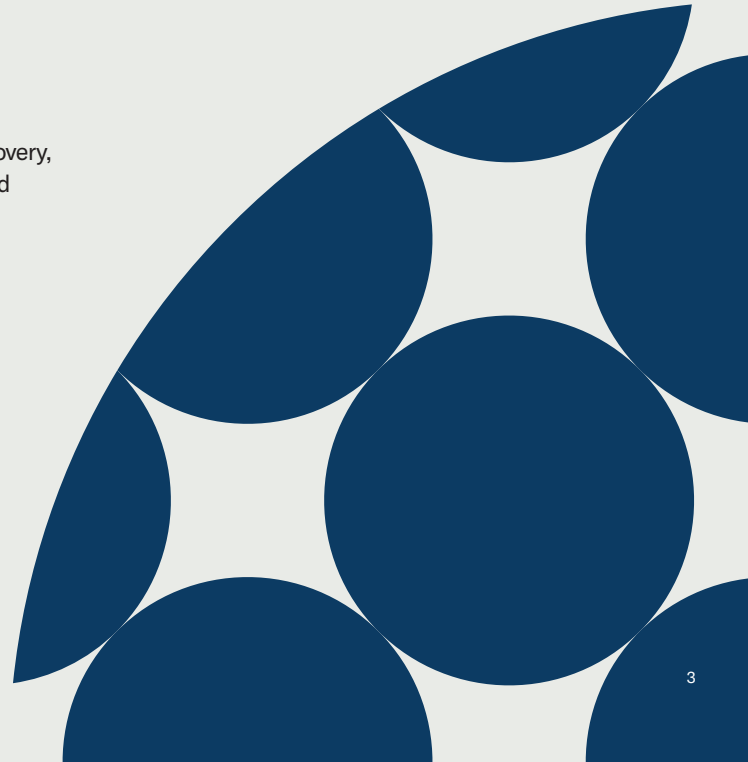

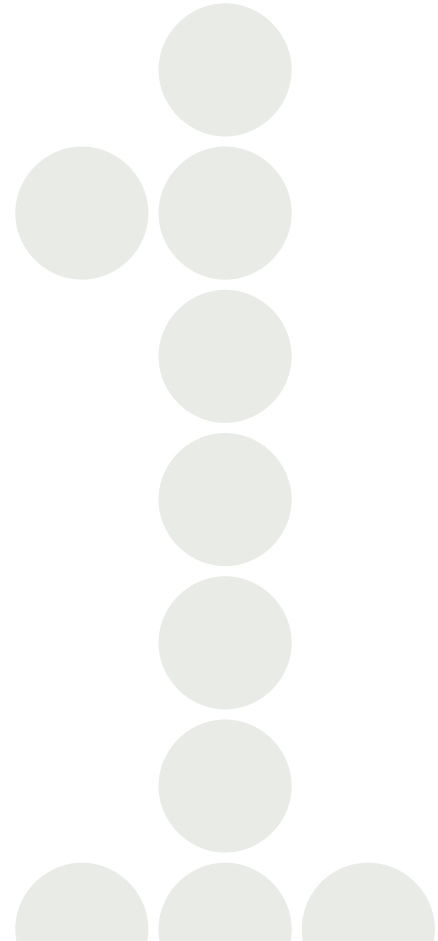

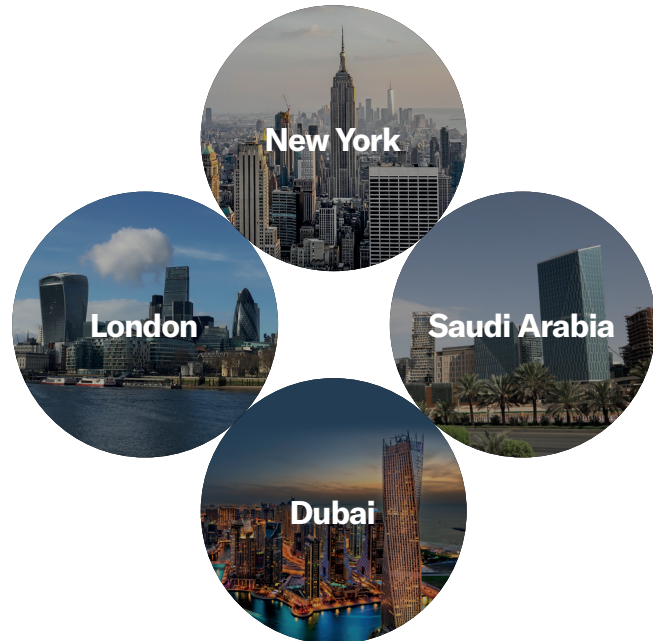
Case study: Zebra Projects

Situation - Zebra Projects provide interior commercial design services to international clients, principally those with global retail brands. They are headquartered in Dubai and have operational centres in the UK, Saudi Arabia and the US.

Solution - AGA's UK (London) engagement team (Alliotts) has been consulted to advise on the local rules and reporting for employees and secondees and the nature of establishing or avoiding the creation of a permanent establishment in the countries in which they do business.
